#### **Agreement:**

- 1) Each Resident/Property Owner will be assigned a Keypad Code to open gate, provided there are no delinquent dues/assessments.
- 2) RFID Stickers are available for purchase by Residents/Property Owners, provided there are no delinquent dues/assessments.
- 3) Upon sale of property, Keypad Codes and RFID access will be deleted/terminated.
- 4) A Transaction Log will automatically record the time & date that a Keypad Code or RFID is used.
- 5) If SFHA dues/assessments are 60 days or more delinquent, Keypad Code/RFID operation may be suspended until payments are current.
